Scholarship Policies

Scholarships at Robert Cavalier University fall under the category of university scholarships for Post Graduate students.

University Scholarship for Post Graduate Students USD 620

University Scholarships to a maximum of USD 620 are awarded by the Chief Academic Officer to incoming postgraduate students who will enhance the academic profile and diversity of their class and the University. Selection is made on the basis of their core grade point average of 2.50 at the undergraduate level at a recognized higher education institution where the medium of instruction is in English.

Financial need is not a criterion for selection.

- Students who are legal residents of the state of Louisiana are eligible to be considered for university scholarships.
- Students who are not legal residents of the state of South Carolina and are lawfully present in the United States are eligible to be considered for a university scholarship.
- International Students who are not residents of the state of Louisiana and residing outside the United States are also eligible to be considered for a university scholarship.
- Scholarship eligibility is limited to the completion of a part-time twelve-month program (12) MBA program of study.
- University Scholarship are granted to first-time, postgraduate students only. The Scholarship award is valid only for the term offered (12 months) as indicated in the award offer.

Robert Cavalier University (RCU) Terms & Conditions

To be awarded a scholarship, you must agree to the following terms and conditions:

1. The money that is allocated toward your scholarship is solely for the purpose of paying your Assessment Fees at RCU. It is not for your personal gain or usage outside your Tuition Fees at RCU. The funds are property of RCU, held in your name, and allocated by RCU toward the payment of your Tuition Fees for the time that you remain enrolled at RCU.

2. In order to continue to receive your scholarship funds, you must maintain a level of Satisfactory Academic Progress. Your scholarship will be at risk if you are placed on Academic Warning and may be withdrawn if you are not meeting the required level of Satisfactory Academic Progress. If you return to Good Academic Standing, please be aware that this scholarship shall not again be made available to you. Information

3. Should you cease your studies, fail to commence your studies, are dismissed for academic or disciplinary reasons from RCU, or your scholarship is withdrawn for failure to maintain a level of Satisfactory Academic Progress, you forfeit your scholarship.

4. Should you decide to return to the University at a later time, and require assistance in paying your Tuition Fees, you will need to re-apply for the University Scholarship. RCU cannot guarantee that the scholarship will be available upon your return.

5. If you are required to repeat courses, you will incur an additional Course Fee for each additional course taken and may not have sufficient funds remaining in your scholarship for the completion of your degree.

6. The award of this scholarship is for up to 10 (ten) Courses Fee of the MBA program only.

7. By accepting these terms and conditions, you indicate your consent to the use of your non-identifying information in general RCU publications. This consent shall remain in full force and effect after the completion of your studies at RCU.

8. You must abide by all policies and procedures of the University as outlined in the RCU Academic Catalog. This includes but is not limited to, strict adherence to the University's Code of Conduct and the Academic Code of Conduct.

9. The University reserves the right to take disciplinary action, including cancellation of this scholarship and termination of your enrollment if, at any time after the award of the scholarship, it has reasonable grounds to suspect that:

- you have been awarded this scholarship on the basis of false statements, misrepresentation, or fraudulent actions; or
- you have encouraged or induced another scholarship applicant to make false statements, misrepresentations, or fraudulent actions in his or her scholarship application, regardless of whether the scholarship is awarded.

10. By accepting this scholarship, you agree to these terms and conditions and all other University policies and procedures, which continue to apply. This includes (but is not limited to) the policies and procedures outlined in the RCU Academic Catalog and Enrollment Agreement.

11. These terms and conditions shall be governed by and construed in accordance with the laws of the State of Louisiana. Any unresolved dispute which is related to these terms and conditions and has not been amicably resolved shall be brought before a



court of competent jurisdiction in the State of Louisiana, which shall have sole jurisdiction in this regard.

12. Provisions regarding the awarding of this scholarship are subject to change.
